# Minutes from Founders Day 2003 Alumni Meeting



The meeting was called to order by President Jenell Jensen. There were many members present in addition to past and present advisors and members of the active chapter.

<u>Secretary's Report -</u> Christina Howard read the minutes of the Sept. 14,2002 meeting. The minutes were approved as read.

<u>Treasurer's Report -</u> Christy Montoya reported the balances to date on our accounts: Checking- \$4064.36, \$1536.34 is operating and \$2528.02 is scholarship CD-\$5520.45 and it is due April 2003

Christy also asked that the 2003 dues be set at \$25, (\$20 in 2002) and proposed to re-instate the lifetime dues at \$300 with payments at \$50 for 6 years. In addition, Christy felt that we need to discuss what to do with the CD. She also reported that membership is 30% paid with 24 lifetime paid, 3 lifetimes are working on payments, and 31 annual. The Treasurer's report was approved as read and discussed.

<u>Website</u>- Carmen reported that she needs new items/photos to update site and that the next newsletter will be on it.

<u>Active relations</u>- Carmen also reported that the goody boxed and donations to care boxes to actives last year went over well.

<u>Social Activities</u>- Jenny reported on last year's activities -the summer zoo outing and fall tailgate party – and asked if anyone had any ideas for 2003.

Actives- Lindsay Stevenson reported on the upcoming activities on behalf of the actives. She said they are working on Promising Young Women and that they are hosting a regional meeting on April 11-13. Several members of the Purdue alumni are coming and they thought it would be nice for us to get together with them sometime that weekend. Also, she asked that as many as possible attend the National Convention which will be in Chicago this year.

Old Business- There was no old business to discuss.

### New Business-

Approval of slate of officers with expiring terms were as follows:

President- Jenell Jensen self nominated. No objections.

Secretary- Christina Howard was nominated and accepted. It was moved and seconded to close nominations. Passed

Member at Large/Webmaster- Carmen Kenney was nominated and accepted. Motion to close was seconded. Passed.

Member at Large vacancy- Sarah Duffy was nominated and accepted. Motion to close was seconded. Passed.

There was a motion to accept slate that was seconded and passed.

Christy reported that we need to discuss what to do with the House CD. There were several suggestions including letting it revolve again or move the money to another financial opportunity and to donate money to the active chapter to develop membership recruiting material. After

lengthy discussion on whether or not finding a house is feasible at this time, Becky Reed moved to roll over the CD or put it into another financial opportunity as the Treasurer sees fit. Seconded and passed.


-Christy also reviewed the Chapter Purpose and Goals and asked for any additions:

- 10. Other ideas included adding active officer list to website to keep everyone informed of active chapter activities and how to get in touch with them.
- Sarah moved to have a meeting April 12 in conjunction with the regional convention and to set up a committee to have a regional alumni get-together. Seconded and passed.

- Sarah moved to adjourn. Seconded and passed.
